NACO's 3rd Annual Legislative Conference will be held on October 23, 2008 at the Holiday Inn & Convention Center in Kearney. This year's slate of speakers include Secretary of State John Gale; Clerk of the Legislature Patrick O'Donnell; Senators Deb Fischer and Annette Dubas; Bill Lock, Research Analyst for the Legislature's Revenue Committee and Tom Bergquist, Legislative Fiscal Analyst.

Education and discussion on important topics such as the legislative process, road funding and state aid to counties will be on this year's agenda. This is also the forum where you will have the opportunity to provide your input into establishing NACO's platform and legislative priorities.

Registration for the conference is only \$30 and includes over five hours of education, break, luncheon and handout material. High Voter Turnout Expected as Election Deadlines Draw Near



With so much focus on this year's presidential race, election officials across the state are gearing up for a larger voter turnout than in previous general elections. Add to that local issues such as jail and school bonds, and that number may increase even more. Many election officials have made the decision to have a larger number of ballots printed for this election in anticipation of a larger turnout.

Since early voting began on September 29, almost 50,000 of the nearly 1,137,000 currently registered voters across the state have taken advantage of the ability to

receive their ballot early. And with more than three weeks left until Election Day, that number could increase by quite a lot. Will that leave poll workers with little to do Election Day? With a fifty-three percent voter turnout in the 2006 General Election, odds are there will still be plenty of voters to keep them busy at the local polling places on Election Day.

Supporting material may include testimonial letters from peers or other printed matter that highlight his or her record of service.

Each of the 2008 nominees will be introduced and recognized during the course of the conference. At the conclusion of the luncheon, the announcement will be made as to who has been chosen by a special selection committee.

The 2008 recipient will join an elite list of county officials who have previously received this award and will receive a handsomely engraved plaque befitting of this prestigious honor.


