A Message from Executive Director Larry Dix...

The NACO Board will consider and vote at their upcoming June 18th meeting to determine the representative from the Nebraska Association of County Officials who will serve as a member of the National Association of Counties board of directors.

The NACO Bylaws (Article IV, Section 2a) states:

There shall also be one (1) nonvoting ex officio Director: the county official appointed annually by the Directors to serve as the Nebraska representative on the National Association of Counties (NACo) Board of Directors, hereinafter called the Ex Officio Director. The Ex Officio Director shall be in addition to the seventeen Directors, unless the person so appointed already serves as an Officer, Metropolitan, District, or Affiliate Director in which event there shall be no Ex Officio Director.

Currently, Tim Loewenstein is the Nebraska representative. Tim was not successful in his bid to serve another term on the Buffalo County Board and therefore will no longer be eligible to serve in this capacity. If you, or you know of anyone, who wishes to be considered for this position, please let me know via email so they can be considered during the June 18th meeting.

I have attached the Nebraska Representative Guidelines as adopted by the NACO Board.

NACO BOARD of Directors Appointment Requirements

Inheritance Tax

During the summer, NACO staff will be compiling inheritance tax information from a random sampling of counties. The information will allow our office to evaluate the effects of 2007 legislation for the inheritance tax exemptions and the rate of the inheritance tax paid to the county during the 2009 calendar year.

Trapping Ban

Nebraska law permits counties to adopt a resolution having the force and effect of law to prohibit the trapping of wildlife in the county road right-of-way or in a certain area of the right-of-way (partial ban). This law was modified in 2009. Prior to the modifications, there was a ban of trapping, except for raptors, in the county road right-of-way.

Of the 75 counties that responded to a survey about whether or not their county currently has a trapping ban in the county road right-of-way, 23 counties or 31% have adopted a prohibition. Three of the counties with a ban have a partial ban to trapping the county road right-of-way.
