Legislature Convenes on Jan. 3, 2007

The 100th Legislature, First Session convened last week with 22 new members taking the oath of office. Sen. Mike Flood of Norfolk was elected Speaker and new leadership was chosen for nearly all of the Unicameral's standing committees. A complete list of new senators, selected committees and contact information appears on the reverse.

The 2007 session is a "long" 90-day session. Bills not adopted at the end of 2006 were killed. Bills not adopted or killed this year will carry over to the 2008 session. Adjournment is tentatively scheduled for May 31. By the end of the seventh day, 342 new bills had been introduced.

Following a recess day in recognition of Martin Luther King, Jr. Day, committee hearings are scheduled to begin on the afternoon of Jan. 16. Among the bills to be heard on Tuesday is a measure to require a single license plate (**LB 14**). Wednesday's hearings include bills to combine voter registration lists and sign-in registers (**LB 44**), limit multiple office-holding (**LB 17**), and five bills on taxation, assessment, liens and homestead exemptions (**LB 166**, **LB 167**, **LB 168**, **LB 155**, **LB 145**). Thursday's hearings include a revision of the Open Meetings Law (**LB 7**). On Friday, hearings will address recall (**LB 18**) and interlocal agreements (**LB 13**).

NACO Legislative Committee Meetings Set for January 19 and 26

NACO's Legislative Committee will meet at the Cornhusker Hotel in Lincoln on Jan. 19 to review and take positions on 2007 legislation. The meeting will begin at 9:30 a.m. in Arbor Rooms 1 and 2, which are located at the bottom of the escalator. A second meeting is planned for Jan. 26 at 9:30 a.m. in Yankee Hill Rooms 1 and 2. After brief preliminary remarks, affiliate groups will meet for discussion of bills pertinent to their membership. After the groups have met, the NACO Legislative Committee will convene as a whole to review and take positions on the entire list of bills. All county officials are encouraged to attend or discuss areas of concern with their NACO Board representative prior to the meeting.
